

RENEWAL SERVICES ORDER FOR DETROIT PUBLIC SCHOOLS COMMUNITY DISTRICT



The scope of services to be provided are described below. The services will be provided pursuant to Khan Academy’s Terms of Service for the District Service as executed between Khan Academy, Inc. (“Khan Academy”) and Detroit Public Schools Community District (the “District”) on August 24, 2020 (“Terms of Service”), which are incorporated herein by reference, as modified by this Renewal Order. This Renewal Order, together with the Terms of Service, are referred to as the “Agreement.”

The Khan Academy District services to be provided comprise rostering support for schools and teachers via Clever SecureSync, data insights on district and school level Website usage provided through district administrator reports, implementation support upon onboarding at the beginning of the academic year, and priority technical support for teachers and staff, and professional development/training and other services set forth below. All technical support will be provided by the customer support team via Khan Academy’s online help center portal.

Licenses: Services will be provided to the number of students set forth above, and their associated teachers. Services do not include custom alignment or creation of custom content.

***Subjects:** Subjects are identified for rostering and implementation support. Upon notice to (and approval by) Khan Academy, Customer may request a change to the indicated subjects.

Fees: Total fees are **\$195,000**. Except as agreed between the parties in writing, each party will bear its own expenses.

This student license fee represents a 50% discount from Khan Academy's standard subscription price (\$10.00 per student) and is a special price offered for the 2022-2023 school year only.

Term: Services are provided for a term of one year, commencing on August 1, 2022, and ending on July 31, 2023. Under no circumstance shall the term of the contract extend beyond July 31, 2023 without a written amendment to this Agreement executed by the Parties in writing (including a renewal purchase order).
